1. SCOPE OF WORKS

The works form part of the main contract works being carried out at Calder Park, Wakefield by Winvic Construction. Any instructions obtained herein are applicable only to these works.

2. ROUTINE MAINTENANCE

In early life, until the joints have fully stabilised, the paving should not be cleaned by use of a mechanical road sweeper, it should be swept by hand only. The block paving will require routine maintenance by brushing at least twice a year. It is recommended that this be carried out in spring and after leaf fall in autumn. Care should be taken not to use suction to a force which would remove the joint filling from the paving.

Under no circumstances should the joints be allowed to become contaminated with soil or any other fine material. Should the joints within the laying course become filled advice should be taken from the manufacturer on how to affect remedial work.

Should any spillage of corrosive or harmful materials occur advice should be taken from the manufacturer as to how to affect cleaning works.

3. EXCEPTIONAL CIRCUMSTANCES

Should replacement of slab paving prove necessary this should be carried out by an experienced maintenance contractor.
